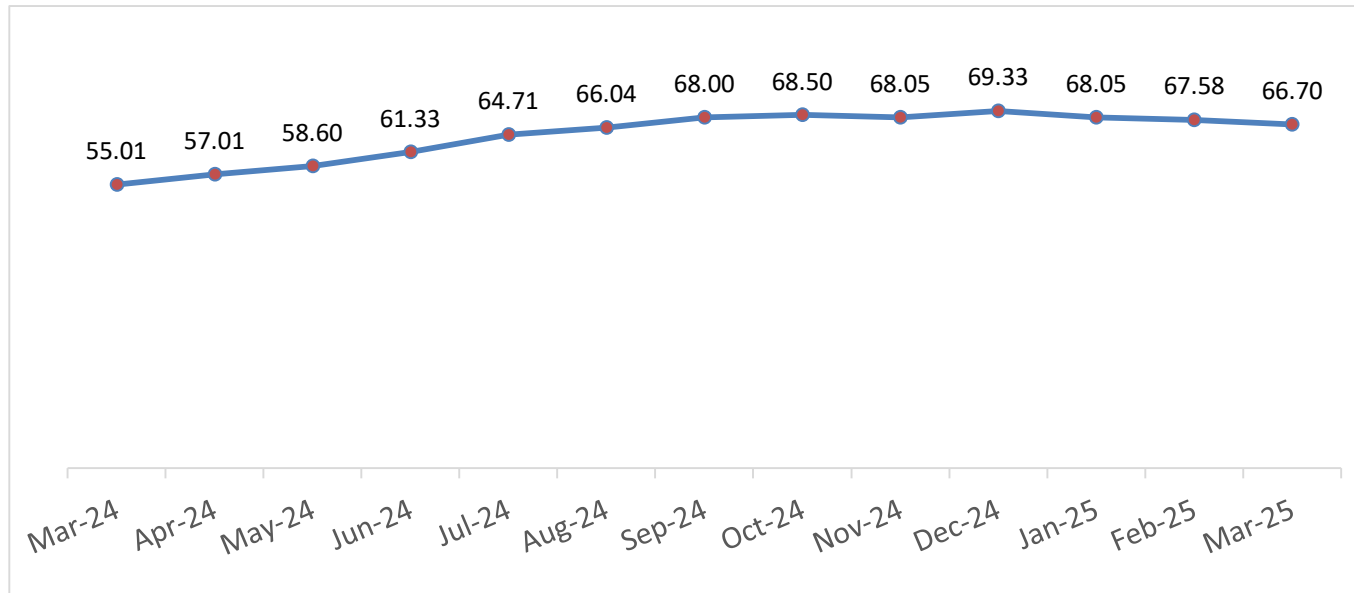




Total Assets (Rs. Trillion)



Assets managed by the Indian mutual fund industry has increased from Rs. 55.01 trillion in Mar 2024 to Rs. 66.70 trillion in Mar 2025. That represents 21.26% increase in assets over March 2024

*Assets are measured as average assets for the month.
Rs. Trillion is equivalent to Rs. lac Cr.*

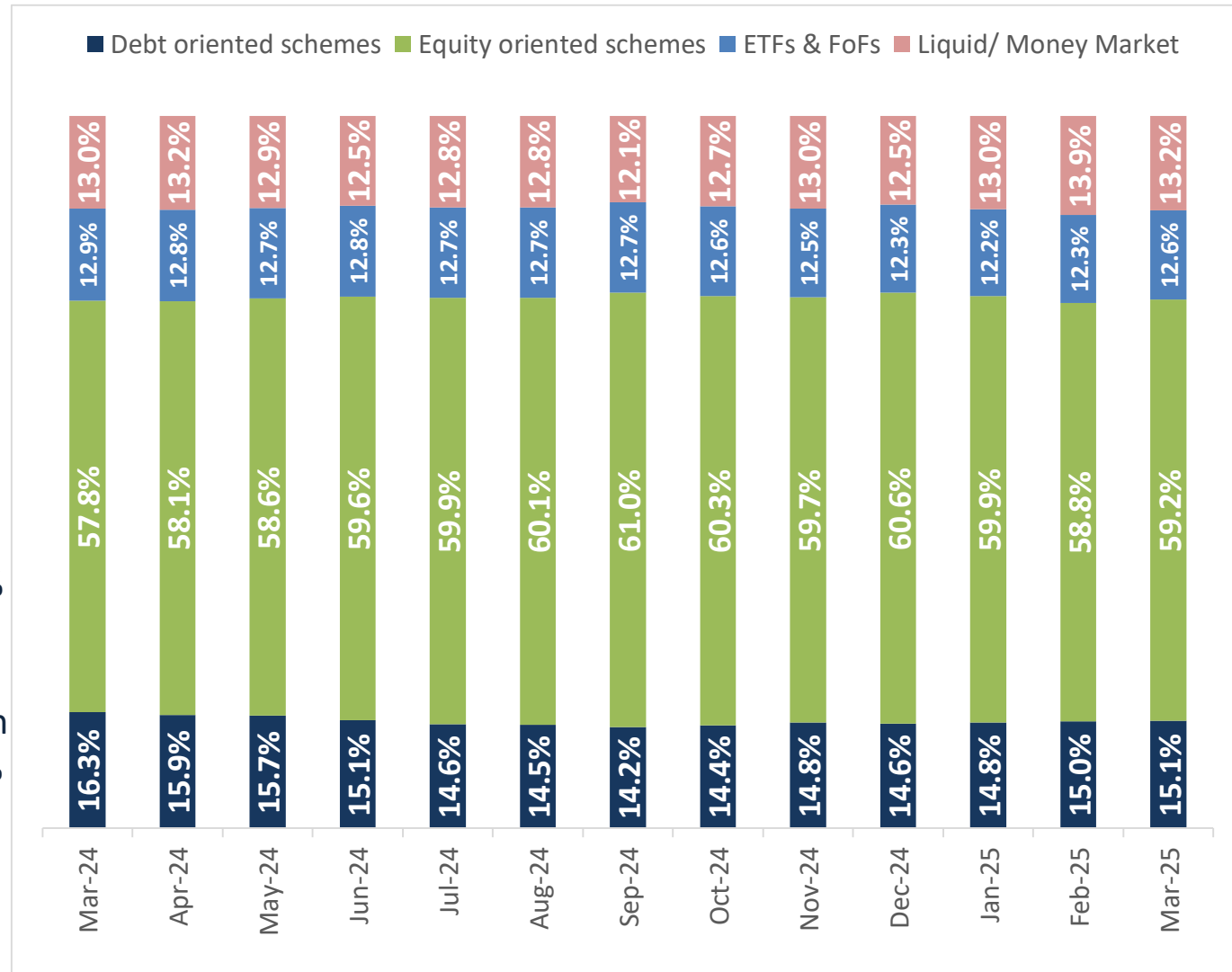
Scheme wise Composition of Assets



The proportionate share of equity-oriented schemes is now 59.2% of the industry assets in Mar 2025, up from 57.8% in Mar 2024.

The proportionate share of debt-oriented schemes is 15.1% of industry assets in Mar 2025, down from 16.3% in Mar 2024.

ETF market share is 12.6% in Mar 2025, down from 12.9% in Mar 2024.



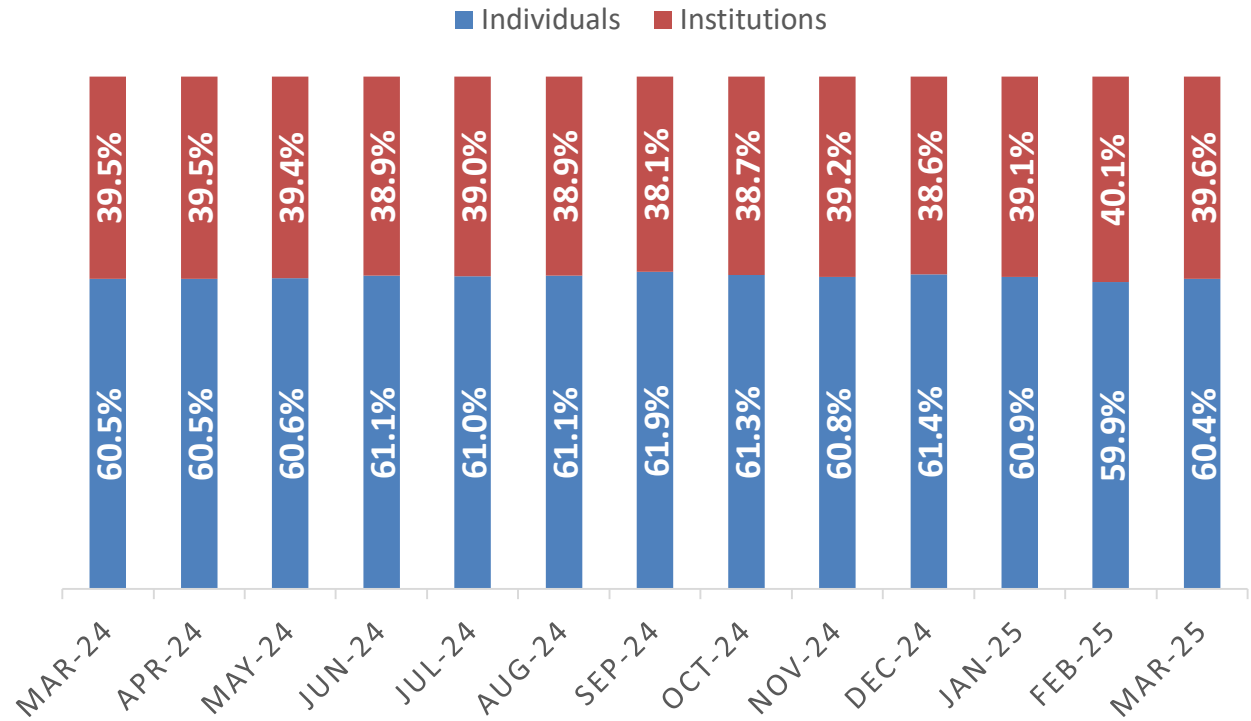

Investor Type-wise Composition of Mutual Fund Assets



Individual investors now hold a relatively lower share of industry assets, i.e. 60.4% in Mar 2025, compared with 60.5% in Mar 2024

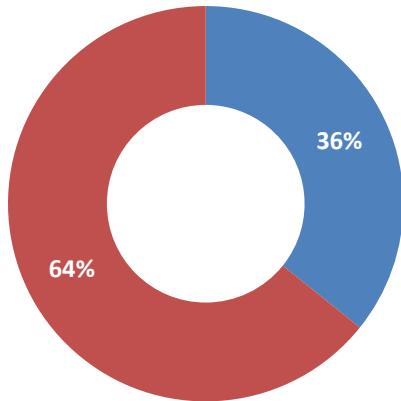
Institutional investors account for 39.6% of the assets, of which corporates are 95%. The rest are Indian and foreign institutions and banks.



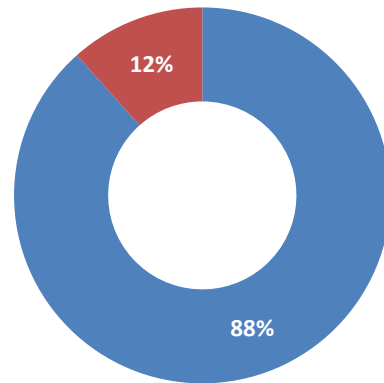
Institutions include domestic and foreign institutions and banks. HNIs are investors who invest with a ticket size of Rs.2 lakhs or above.

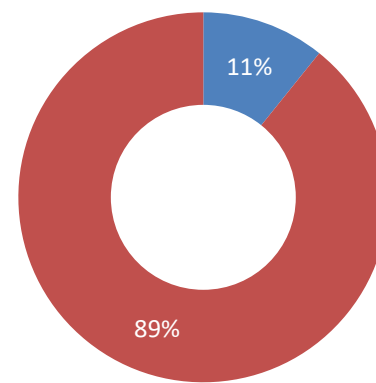

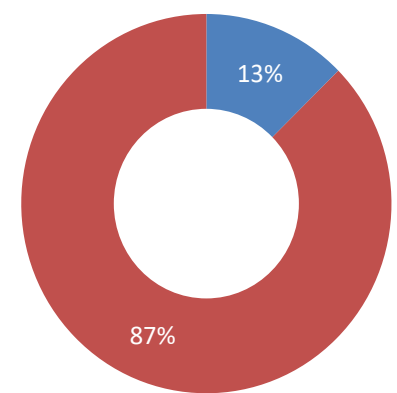
Equity Oriented Schemes

Equity-oriented schemes derive 88% of their assets from individual investors (Retail + HNI)

Institutional investors dominate liquid and money market schemes (89%), debt-oriented schemes (64%) and ETFs, FOFs (87%).

- Institutional investors dominated liquid and money market schemes (87%), debt-oriented schemes (60%) and ETFs, FOFs (90%).

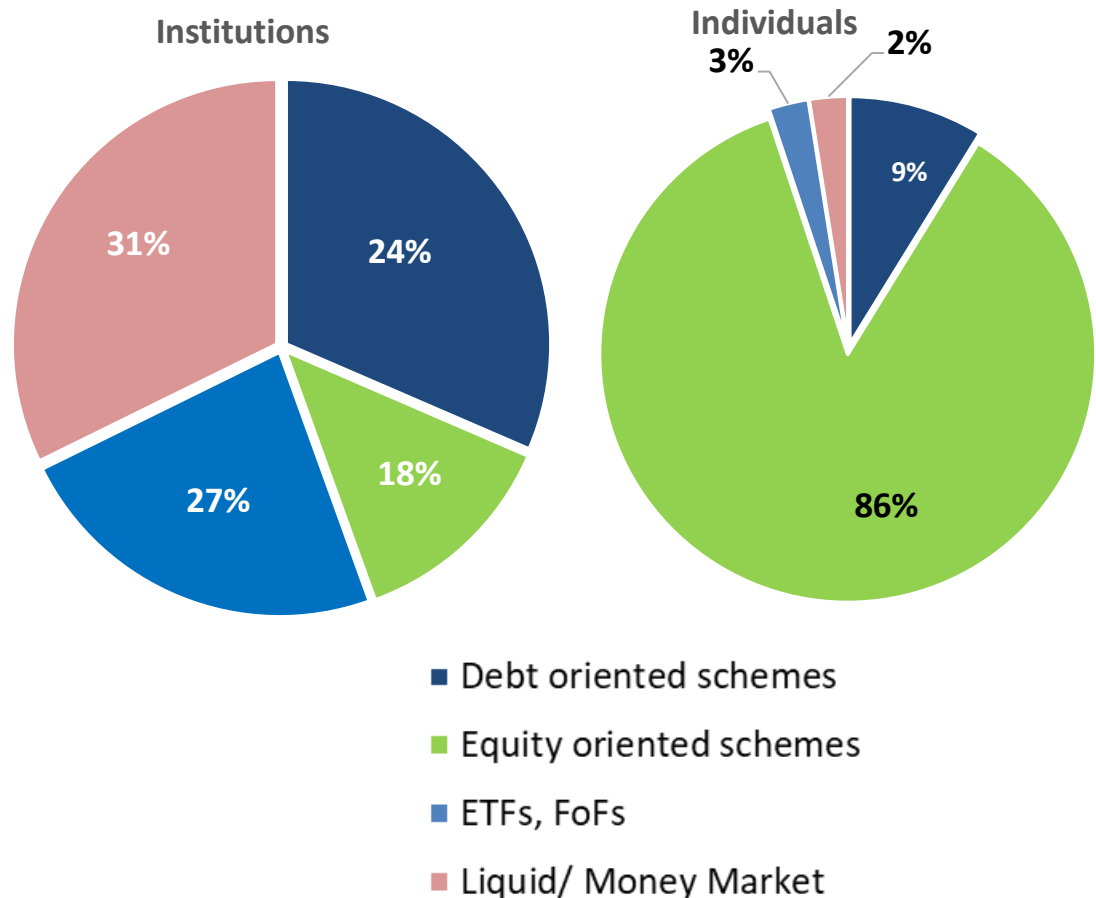

Composition of Investors' Holdings

Individual investors primarily hold equity-oriented schemes while institutions hold liquid, debt-oriented schemes and ETFs, FoFs

86% of individual investor assets are held in equity-oriented schemes.

55% of institutions assets are held in liquid / money market schemes and debt-oriented schemes.



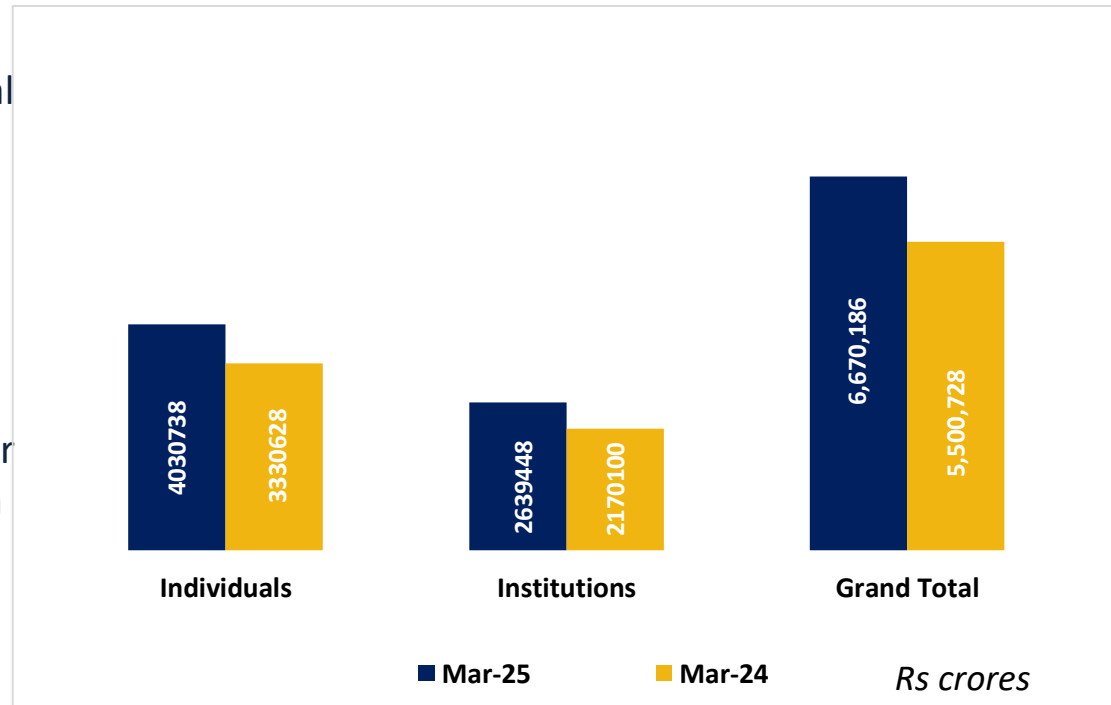

Growth in Assets



The value of assets held by individual investors in mutual funds increased from Rs.33.31 lac cr in Mar 2024 to Rs. 40.31 lac cr in Mar 2025, an increase of 21.02%.

The value of Institutional assets has increased from Rs.21.70 lac cr in Mar 24 to Rs.26.39 lac cr in Mar 2025 an increase of 21.63%.
